
Portland Metropolitan Area: March 2021

The Portland metropolitan area's unemployment rate was 6.1% in March, essentially unchanged from February (6.2%). The statewide and national rates were 6.0%. Approximately 83,400 area residents remain unemployed; 30,000 more than a year ago.

Employers added 7,500 jobs in March following a gain of 10,300 in February (seasonally adjusted). Since the start of the recovery in May, the region has regained 85,700 jobs, or 48% of March and

April losses (-179,600). In comparison, Oregon has added back 54% of lost jobs and the U.S. has recovered 62%.

Employment in leisure and hospitality surged in March (+8,600 jobs) following strong gains in February (+5,500) as restaurants resumed (limited) indoor seating. This industry lost half of its jobs in the first month of the pandemic. It has regained 24,500 jobs since April 2020, or just 40% of losses.



Construction, manufacturing, and

transportation and warehousing all posted larger-than-typical gains in March. Most other major industries performed close to seasonal trends.

Over the year, employment in the metro area is down 80,900 jobs, or -6.6%. Most published industries remain in the red with the exception of transportation and warehousing (+5,600 jobs; +12.3%), professional and technical services (1,300; 1.6%), general merchandise stores (900; 4.0%), grocery stores (600; 2.5%), and state government (700; 5.8%) – all of which have experienced an increase in demand due to the pandemic.

The Oregon Employment Department will release the Portland metropolitan area's unemployment rate and employment survey data for April on Tuesday, May 25.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.

Nonfarm Payroll Employment: Offical Oregon Series. Data are by place of w ork and cover full- and part-time employees w ho w orked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family w orkers, and domestics.

The Portland-Vancouver-Hillsboro metropolitan area includes Clackamas, Columbia, Multnomah, Washington, and Yamhill counties in Oregon, and Clark and Skamania counties in Washington State.
