Employment in Morrow & Umatilla Counties: November 2025

Morrow County's seasonally adjusted unemployment rate was 4.9% in November and 4.9% in September. The November rate ranks it in a tie with Deschutes and Malheur counties for 3rd lowest among Oregon's 36 counties. The October unemployment rate is not available since underlying data was not collected due to the federal government shutdown that month. Over the year, Morrow County's seasonally adjusted unemployment rate is up from 4.0% in November 2024.

Morrow County's seasonally adjusted nonfarm employment was unchanged at 5,890 in November compared to October. Not seasonally adjusted private industry decreased by 40 jobs to total 4,760, and government dropped 10 jobs to total 1,110. Manufacturing had a significant loss of 30. In the public sector, local government decreased by 10 jobs.

Morrow County's private-industry employment gained 40 jobs over the year ending in November. Private industry dropped 50 jobs since November 2024. There were losses in professional and business services (-160), manufacturing (-80), and wholesale trade (-20). There were gains in construction (80), and transportation, warehousing, and utilities (50). Government employment rose by 90 jobs over the year, with local government adding 100 jobs and state government dropping 10.

Umatilla County's seasonally adjusted unemployment rate was 5.6% in November and 5.5% in September. The November rate ranks 18th lowest among Oregon's 36 counties. The October unemployment rate is not available since underlying data was not collected due to the federal government shutdown that month. Umatilla County's seasonally adjusted unemployment rate is up from 4.7% in November 2024.

Umatilla County's seasonally adjusted nonfarm employment dropped 150 jobs in November compared to October. Not seasonally adjusted private industry decreased by 210 jobs to total 22,150 and government gained 40 jobs to total 8,200. There were significant losses in leisure and hospitality (-110), transportation, warehousing, and utilities (-60), and mining, logging, and construction (-30). There were significant gains in local education (80), and private education and health services (40).

Umatilla County's private-industry employment gained 200 jobs over the year ending in November. Private industry gained 70 jobs since November 2024. There were gains in private education and health services (90), manufacturing (60), information (60), and mining, logging and construction (40). There were losses in leisure and hospitality (-70), retail trade (-60), and professional and business

services (-40). Government employment rose by 140 jobs over the year, with local government adding 100 jobs, federal government adding 20 jobs and state government adding 20 jobs.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
