## **Employment in Morrow & Umatilla Counties: April 2025**

Umatilla County's seasonally adjusted unemployment rate increased by 0.1 percentage point to 5.0% in April. Over the year, Umatilla County's seasonally adjusted unemployment rate rose by 0.7 percentage point. It tied as the county's fourth lowest April rate since comparable statistics began in 1990.

Umatilla County's nonfarm employment total rose by 120 jobs to 30,180 in April. Private industry increased by 130 jobs in April, rising to 22,300, and government dropped 10 jobs to 7,880. Mining, logging, and construction increased its total in April, climbing to 1,560, a gain of 60. Leisure and hospitality added 40 jobs, rising to 2,850. Manufacturing followed, adding 30 jobs to total 2,700. In the public sector, local education decreased by 40 jobs, federal government added 20 jobs, Indian tribal added 10, and state government and other local government held steady.

Umatilla County's total private industry employment increased by 110 jobs over the year ending in April (+0.5%). Private education and health services led private-industry gains, rising by 230 jobs (+5.3%), followed by information, up 90 jobs (+11.8%) over the year. Retail trade led losses, falling by 140 jobs (-4.1%). Leisure and hospitality dropped 50 jobs over the year. Government employment decreased by 80 jobs over the year, led by a loss of 120 in local education. Other local government fell by 30 jobs, federal government decreased by 10, state government added 80, and Indian tribal held steady.

Morrow County's seasonally adjusted unemployment rate increased by 0.1 percentage point in April to 4.8%. Over the year, Morrow County's seasonally adjusted unemployment rate rose by 0.9 percentage point.

Morrow County's nonfarm employment increased to 5,780 in April, a gain of 20 jobs. Private industry increased by 20 jobs, rising to 4,930 jobs, and government held steady at 850. Professional and business services increased by 30 jobs to lead gains. Manufacturing; transportation, warehousing, and utilities; and leisure and hospitality dropped 10 jobs each to lead losses. In the public sector, federal government, state government, and local government all held steady.

Morrow County's private-industry employment rose by 190 jobs over the year ending in April (+4.0%). Private industry's over-the-year growth was led by a gain in construction, up 50 jobs, followed by gains of 20 jobs each in retail trade and professional and business services. Losses were confined to wholesale trade and transportation, warehousing, and utilities, down 10 jobs each. Government

employment fell by 230 jobs over the year, with local government shedding 230 jobs, while federal government and state government held steady.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
