





#### Job Growth by U.S. Metro

Percentage Growth - Mar. 2022 to Mar. 2023




## **Employment Growth by County**

Apr. 2022 to Apr. 2023 - By County




#### **Employment in Portland Metro**

Jan. 2020 to Apr. 2023 (seasonally adjusted)




#### Select Industry Gains and Losses

Multnomah County, Apr. 2022 to Apr. 2023




### **Unemployment Rate Portland Metro**

# Real Wages Have Increased Since Pre-Pandemic

From April 2019 to April 2023, real total private hourly wages increased in Oregon by 6% and in the Portland MSA by 4%. Growth in average wages has outpaced high inflation due largely to record high labor demand and a tight labor market.

Tight labor market conditions and job switching has especially affected low wage jobs, like those in the leisure and hospitality sector. Low wage industries have needed to increased their wages by larger margins than firms in high wage industries, like professional and business services, in order to meet labor demand. As a result, there's been considerable wage compression in Oregon. In other words, the difference in wages between high-wage occupations and low-wage occupations has shrunk.
