First Quarter 2024: Oregonians at Work

Oregon employers must report total wages and hours worked for each employee covered by unemployment insurance. These quarterly records cover more than two million individuals employed in the state but don't include roughly 230,000 self-employed workers. Past quarterly wage reports are available in the Oregonians @ Work drop-down menu at www.qualityinfo.org/data.

Oregon had 1.98 million people working in jobs covered by the state's unemployment insurance system during the first quarter of 2024. This was a decrease of 5,100, or -0.3%, from the same quarter of the previous year. They earned a total of \$34.2 billion, with an average wage of about \$17,300 per worker for the quarter. The median hourly wage during the quarter was \$27.67.

All fourteen industries had real wage gains, meaning that the median wage increased more than inflation. Local government had the largest real gain in median wage percentage growth from first quarter 2023 to first quarter 2024 (3.2%), followed by construction with 2.9% wage growth over the year.

Of the 17,400 jobs lost between first quarter 2023 and first quarter 2024, retail trade experienced the largest decrease in both numerical change (-9,900) and percentage change (-4.4%). The largest increase in both numerical change and percentage change occurred in health care and social assistance (+15,600; +5.0%).

Looking at the industries that gained jobs between first quarter 2023 and first quarter 2024, two industries made up the majority of those gains. Health care and social assistance and local government made up 93% of the job growth. These two industries had gains over 9,000 while the rest were under 1,600.

To provide better data, this analysis also filters out job records that probably contain errors. Jobs that report zero hours or more than 999 hours (about 77 hours per week) worked in a quarter and jobs that paid less than the federal minimum wage (\$7.25 per hour) are excluded. Jobs that paid more than \$500 per hour and reported less than 10 hours work during the quarter are also excluded.
