
Employment in Central Oregon: November 2024

Total nonfarm employment increased year-over-year across all three Central Oregon counties. Seasonally adjusted unemployment rates remained stable in November, showing little to no change.

<u>Crook County:</u> The seasonally adjusted unemployment rate decreased marginally over the month of

November and is now 5.5%, down from 5.6% in October—in November of last year, it was 5.9%. The unemployment rate is 1.0 percentage point above the record low set before the pandemic when it was 4.5%.

Crook County lost 120 jobs (-1.6%) in November, with most losses occurring in the public sector (-70 jobs); and leisure and hospitality (-40 jobs). Gains were minimal and seen in wood product manufacturing, information, and other services (+10 jobs each).



The county gained 150 jobs in the last year (+2.1%). Notable job gains were seen in leisure and hospitality (+60 jobs), other services (+50 jobs), and information (+40 jobs). Private job losses were concentrated in manufacturing (-20 jobs) and mining and logging (-20 jobs).

<u>Deschutes County (Bend-Redmond MSA):</u> The seasonally adjusted unemployment rate remained unchanged from October to November at 4.0%. November's unemployment rate remains 0.7 percentage point above its record low of 3.3% before the onset of the pandemic.

The Bureau of Labor Statistics estimates that Deschutes County lost 360 jobs (-0.4%) from October to November and total nonfarm employment is now 98,520. Job losses were concentrated in leisure and

hospitality (-450 jobs) and financial activities (-130 jobs). Most gains were seen in trade, transportation, and utilities (+200 jobs) and private education and health services (+130 jobs).

Total nonfarm employment increased by 4.2% (+4,010 jobs) from November 2023 to November 2024. Over-the-year job gains were concentrated in private education and health services (+1,470 jobs); leisure and hospitality (+880 jobs); and the public sector (+790 jobs). Other notable gains took place in trade, transportation, and utilities (+300 jobs); and mining, logging, and construction (+220 jobs). The only over-the-year losses occurred in the financial activities industry with a loss of 30 jobs over the year.

<u>**Iefferson County:**</u> The seasonally adjusted unemployment rate was unchanged in November, holding firm at 4.7%. Last year the unemployment rate was also 4.7% in November. Shortly before the first impacts from COVID-19 were felt the unemployment rate was 4.3%.

Total nonfarm employment lost 10 jobs in November (-0.1%) with losses concentrated in leisure and hospitality (-40 jobs). Construction, retail trade, financial activities, and other services lost 10 jobs each. Over-the-month job gains were concentrated primarily within manufacturing (+50 jobs); and the public sector (+20 jobs).

Jefferson County's total nonfarm employment increased by 140 jobs over the past year (+2.1%). Job gains were concentrated in manufacturing (+90 jobs); the public sector (+70 jobs); and private education and health services (+50 jobs). Losses were mainly seen in construction (-40 jobs), financial activities (-30 jobs), and professional and business services (-20 jobs).

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
