Employment in Clatsop County: May 2024

Seasonally adjusted employment increased by 20 in May

Seasonally adjusted nonfarm payroll employment increased by 20 in May to 19,530 jobs. Seasonally adjusted figures compare expected changes with actual changes. An increase of 380 jobs was expected for the month, and the county added 400 jobs. The private sector added 310 jobs, and total government employment increased by 90. Food manufacturing added 120 jobs. Leisure and hospitality gained 110 jobs. Local government, including education, added 80 jobs.

May's total nonfarm employment was up from the previous year by 220 jobs, an increase of 1.1%. Some major industries gained jobs over the past year, but others have plateaued or shed a few. Private education and health services added 170 jobs. Construction added 70 jobs. Food manufacturing dropped 140 jobs. Local government excluding education added 70 jobs.

Clatsop County's seasonally adjusted unemployment rate was 3.9% in May. It was unchanged from 3.9% in April. The rate was 3.5% the year before. The statewide unemployment rate was 4.2% in May, and the national rate was 4.0%.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
