Employment in Morrow & Umatilla Counties: July 2024 Unemployment Rates Remain Relatively Low in July

Umatilla County's seasonally adjusted unemployment rate rose by 0.1 percentage point to 4.0% in July. Ranked among Oregon's 36 counties, Umatilla County placed 12th, tied with three other counties. Over the year, Umatilla County's seasonally adjusted unemployment rate fell by 0.3 percentage point. It ranked as the county's lowest July rate since comparable statistics began in 1990.

Umatilla County's nonfarm employment total fell to 29,520 in July, a loss of 720 jobs. Private industry added 30 jobs in July, climbing to 22,180, and government dropped 750, falling to 7,340. Private education and health services increased its total in July, climbing to 4,410, a gain of 40. Leisure and hospitality added 20 jobs. Private job losses were led by a drop of 30 jobs in transportation, warehousing, and utilities. In the public sector, local education decreased by 930 jobs as schools shuttered jobs for the summer break. Other local government increased by 90 jobs, Indian tribal rose by 50, federal government added 40, and state government went unchanged.

Umatilla County's total private industry employment decreased by 500 jobs over the year ending in July (-2.2%). Professional and business services led private-industry decline, falling by 650 jobs resulting mostly from a non-economic code change (a correction or reclassification in our administrative records). Leisure and hospitality dropped 190 jobs and retail trade cut 130. Private education and health services increased by 150 jobs (+3.5%) over the year. Mining, logging, and construction added 110 and manufacturing rose by 90. Government employment increased by 190 jobs over the year, led by a gain of 90 in other local government. Local education rose by 80 jobs, federal government increased by 40, and state government added 10, while Indian tribal cut 30 jobs.

Morrow County's seasonally adjusted unemployment rate increased by 0.1 percentage point in July to 3.7%, ranking in a tie for sixth among Oregon counties with Clackamas County. Over the year, Morrow County's seasonally adjusted unemployment rate rose by 0.3 percentage point. It ranked as the county's second lowest July rate behind only July 2023.

Morrow County's nonfarm employment fell to 5,650 in July, a loss of 210 jobs. Private industry dropped 20 jobs, slipping to 4,740 jobs, while government decreased by 190, falling to 910. Transportation, warehousing, and utilities and private education and health services dropped 10 jobs each. Gains were

confined to construction, up 10. In the public sector, local government dropped 200 jobs as schools shut down for summer, while federal government added 10 jobs and state government went unchanged.

Morrow County's private-industry employment rose by 160 jobs over the year ending in July (+3.5%). Private industry's over-the-year growth was led by construction (+100), followed by manufacturing and private education and health services, each up 30. Small losses were spread across several other industries. Government employment fell by 90 jobs over the year, with local government shedding 80 jobs and federal government cutting 10, while state government held steady.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
