Employment in Morrow & Umatilla Counties: August 2024 Unemployment Rates Hold Steady in August

Umatilla County's seasonally adjusted unemployment rate held steady at 4.0% in August. Ranked among Oregon's 36 counties, Umatilla County placed 13th, tied with four other counties. Over the year, Umatilla County's seasonally adjusted unemployment rate fell by 0.2 percentage point. It ranked as the county's lowest August rate since comparable statistics began in 1990.

Umatilla County's nonfarm employment total rose to 29,590 in August, a gain of 70 jobs. Private industry added 80 jobs in August, climbing to 22,260, and government dropped 10, falling to 7,330. Professional and business services increased its total in August, climbing to 1,320, a gain of 40. Retail trade and leisure and hospitality each added 30 jobs. Private job losses were led by a drop of 50 jobs in manufacturing. In the public sector, other local government decreased by 110 jobs, local education increased by 100 jobs, federal government rose by 10, state government cut 10, and Indian tribal went unchanged.

Umatilla County's total private industry employment decreased by 370 jobs over the year ending in August (-1.6%). Professional and business services led private-industry decline, falling by 650 jobs resulting mostly from a non-economic code change (a correction or reclassification in our administrative records). Retail trade dropped 100 jobs and leisure and hospitality cut 30. Private education and health services increased by 180 jobs (+4.2%) over the year. Mining, logging, and construction added 80 and manufacturing rose by 70. Government employment increased by 140 jobs over the year, led by a gain of 120 in local education. Federal government rose by 30 jobs, state government increased by 20, while Indian tribal cut 30 jobs and other local government went unchanged.

Morrow County's seasonally adjusted unemployment rate held steady in August at 3.7%, ranking in a four-way tie for sixth among Oregon counties. Over the year, Morrow County's seasonally adjusted unemployment rate rose by 0.3 percentage point. It ranked as the county's second lowest August rate behind only August 2023.

Morrow County's nonfarm employment rose to 5,620 in August, a gain of 80 jobs. Private industry added 60 jobs, climbing to 4,800 jobs, while government increased by 20, rising to 820. Transportation, warehousing, and utilities increased by 20 jobs to lead gains. Losses were confined to leisure and

hospitality, down 10. In the public sector, local government added 20 jobs, while federal government and state government went unchanged.

Morrow County's private-industry employment rose by 190 jobs over the year ending in August (+4.1%). Private industry's over-the-year growth was led by construction (+80), followed by manufacturing and private education and health services, each up 40. Losses were confined to leisure and hospitality, down 20. Government employment fell by 200 jobs over the year, with local government shedding 190 jobs and federal government cutting 10, while state government held steady.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
