# **Employment in Columbia County: October 2023**

## Seasonally adjusted employment decreased by 180 in October

Seasonally adjusted nonfarm payroll employment decreased by 180 in October to 12,070 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 80 jobs is normal for the month, but the county's payroll employment decreased by 100. The private sector lost 130 jobs, and government employment increased by 30. Paper manufacturing lost 70 jobs. Local education, a component of local government, added 50 jobs.

October's total nonfarm employment numbers showed a loss of 70 jobs compared with one year before, a decrease of 0.6%. Some major industries gained jobs over the past year. Private education and health services was up 120 jobs. On the other hand, manufacturing was down 280 jobs, and professional and business services was down 60 jobs. Local government was up by 100 jobs.

Columbia County's seasonally adjusted unemployment rate was 4.1% in October, unchanged from 4.1% in September. It was 4.8% the year before. The statewide unemployment rate was 3.6% in October, and the national rate was 3.9%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
