## **Employment in Columbia County: June 2024**

# Seasonally adjusted employment increased by 30 in June

Seasonally adjusted nonfarm payroll employment increased by 30 in June to 11,860 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 50 jobs was expected for the month, but the county's payroll employment grew by 80. The private sector gained 70 jobs, and government employment increased by 10. Construction and professional and business services added 20 jobs each. Other industries had small job changes or were unchanged.

June's total nonfarm employment numbers showed a loss of 240 jobs compared with one year before, a decrease of 2%. Some major industries gained jobs over the past year. Professional and business services was up 30 jobs. On the other hand, paper manufacturing was down 200 jobs. Leisure and hospitality dropped 80 jobs. Local education, a component of local government, was down 70 jobs.

Columbia County's seasonally adjusted unemployment rate was 4.8% in June, down from 4.9% in May. It was 4.1% the year before. The statewide unemployment rate was 4.1% in June, and the national rate was 4.1%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
