Employment in Columbia County: October 2024

Seasonally adjusted employment increased by 10 in October

Seasonally adjusted nonfarm payroll employment increased by 10 in October to 12,220 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 30 jobs was expected for the month, and the county's payroll employment increased by 40. The private sector lost 20 jobs, and government employment increased by 60. Construction lost 20 jobs. Local education gained 80 jobs. Other industries had little or no job change over the month.

October's total nonfarm employment was up from the previous year by 270 jobs, an increase of 2.2%. Some broad sectors gained jobs over the past year. The largest gain occurred in professional and business services, which added 110 jobs (+10.5%). On the other hand, paper manufacturing lost 80 jobs. Local education, a component of local government, was down 60 jobs over the year.

Columbia County's seasonally adjusted unemployment rate was 4.7% in October, essentially unchanged from 4.6% in September. It was 4.7% the year before. The statewide unemployment rate was 4.0% in October, and the national rate was 4.1%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
