# **Employment in Columbia County: December 2024**

## Seasonally adjusted employment unchanged in December

Seasonally adjusted nonfarm payroll employment was unchanged in December at 12,190 jobs. Seasonally adjusted figures compare expected changes with actual changes. A loss of 60 jobs was expected for the month, and the county's payroll employment decreased by 60. The private sector lost 60 jobs, and government employment was unchanged. Professional and business services lost 20 jobs. Other industries had little or no job change over the month.

December's total nonfarm employment was up from the previous year by 320 jobs, an increase of 2.7%. Some broad sectors gained jobs over the past year. The largest gain occurred in leisure and hospitality, which added 90 jobs (+6.7%). Trade, transportation, and utilities was up 80 jobs over the year. Local government, including education, was down 60 jobs over the year.

Columbia County's seasonally adjusted unemployment rate was 4.7% in December, unchanged from 4.7% in November. It was 4.7% the year before. The statewide unemployment rate was 4.1% in December, and the national rate was 4.1%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
