Employment in the Columbia Gorge: September 2024

Unemployment Rates Little Changed Over the Month and Year Ending in September

In September, Hood River County's seasonally adjusted unemployment rate was little changed at 3.1%. Hood River County's unemployment rate ranked as Oregon's second lowest, just above Wheeler's 3.0%. Over the year, the county's seasonally adjusted unemployment rate edged up by 0.1 percentage point.

Hood River County's nonfarm employment rose by 140 in September and was estimated at 12,010 jobs. Although private employment decreased over the month (-170 jobs), public employment in local education (+330 jobs) led to gains.

Hood River County's private industry employment increased by 120 jobs over the year ending in September, a gain of 1.2%. Jobs were added in leisure and hospitality (+180); trade, transportation, and utilities (+110 jobs); and private education and health services (+60). The majority of losses were seen in professional and business services (-120) and manufacturing (-80).

Wasco County's seasonally adjusted unemployment rate was unchanged from the previous month and was 4.0% in September. Over the year, Wasco County's seasonally adjusted unemployment rate also remained unchanged at 4.0%

Wasco County's nonfarm employment decreased by 40 to reach 10,250 in September. Private industry lost 90 jobs, declining to 8,260, while government rose by 50 to reach 1,990 jobs. Leisure and hospitality lost 90 jobs, and other industries showed little change over the month.

Wasco County's private-industry employment fell by 30 jobs over the year ending in September. Losses were concentrated in the public sector (-130 jobs); transportation, warehousing, and utilities (-30); financial activities (-30); professional and business services (-20); and private education and health services (-20 jobs). On the other hand, job gains were concentrated in construction (+40) and wholesale trade (+20).

Gilliam County's seasonally adjusted unemployment rate was unchanged in September at 4.7%, remaining flat over the year. Gilliam County's nonfarm employment fell by 15 in September with 855 jobs. Over the year, the private sector lost 15 jobs (-2.6%), while government employment rose by 10 jobs and now totals 300 jobs.

Sherman County's seasonally adjusted unemployment rate edged down in September to 3.5% and declined by 0.6 percentage point over the year. Sherman County's nonfarm employment fell by five in September and stood at 990. Local government gained 15 jobs and trade, transportation, and utilities lost 15 jobs over the month. Over the year ending in September, private industry added 20 jobs, and now stands at 665, with the trade, transportation, and utilities industry adding the most during this time (45 jobs).

Wheeler County's seasonally adjusted unemployment rate also edged upward in September and is now 3.0%, still making it the lowest seasonally adjusted unemployment rate in Oregon. Over the year, Wheeler County's seasonally adjusted unemployment rate was up by 0.1 percentage point. Nonfarm employment increased by 10 and reached 390 jobs in September. Over the year ending in September, private-industry employment rose by 15 and was estimated at 205, and government fell by 10 to reach 185.

The Oregon Employment Department plans to release the October county and metropolitan area unemployment rates and employment survey data on Tuesday, Nov. 19, and the statewide unemployment rate and employment survey data for October on Thursday, Nov. 14.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
