Employment in the Columbia Gorge: October 2024 Unemployment Rates Remain Little Changed Over the Month

In October, Hood River County's seasonally adjusted unemployment rate was little changed at 3.2%. Hood River County's unemployment rate ranked as Oregon's second lowest, just above Wheeler's 3.0%. Over the year, the county's seasonally adjusted unemployment rate edged up by 0.1 percentage point.

Hood River County's nonfarm employment decreased by 10 (-0.1%) in October and was estimated at 11,810 jobs. While private employment decreased over the month (-20 jobs), public employment gained 10 jobs.

Hood River County's private industry employment decreased by 140 jobs over the year ending in October, a loss of 1.3%. Jobs were lost in manufacturing (-90); mining, logging, and construction (-20 jobs); leisure and hospitality (-20); and information (-10). The majority of gains were seen in private education and health services (+50); trade, transportation, and utilities (+30); and the public sector (+30).

Wasco County's seasonally adjusted unemployment rate was unchanged from the previous month and was 4.0% in October. Over the year, Wasco County's seasonally adjusted unemployment rate also remained unchanged at 4.0%

Wasco County's nonfarm employment decreased by 110 to reach 10,390 in October. Private industry lost 140 jobs, declining to 8,040, while government rose by 30 to reach 2,350 jobs. In the private sector leisure and hospitality lost 110 jobs, while other services lost 20 jobs, with little to no change in all other industries.

Wasco County's private-industry employment fell by 130 jobs over the year ending in October. Losses were concentrated in professional and business services (-40 jobs); manufacturing (-30); and private education and health services (-20). Gains were minimal and concentrated in mining, logging, and construction (+20) and leisure and hospitality (+20).

Gilliam County's seasonally adjusted unemployment rate increased slightly in October and is now 4.8% but remains flat over the year. Gilliam County's nonfarm employment fell by five in October with 895

jobs. Over the year, the private sector gained 65 jobs (+11.8%), while government employment decreased by five jobs and now totals 280 jobs.

Sherman County's seasonally adjusted unemployment rate edged down in October to 3.5% and declined by 0.6 percentage point over the year. Sherman County's nonfarm employment fell by 25 in October and stood at 950. Local government lost 25 jobs with little to no movement in the private sector over the month. Over the year ending in October, private industry lost 25 jobs and now stands at 630, down by 3.8%.

Wheeler County's seasonally adjusted unemployment rate remained unchanged in October at 3.0%, making it the lowest seasonally adjusted unemployment rate in Oregon. Over the year, Wheeler County's seasonally adjusted unemployment rate was up by 0.1 percentage point. Nonfarm employment increased by five and reached 390 jobs in October. Over the year ending in October, private-industry employment rose by 10 and was estimated at 190, similarly government employment rose by five to reach 200.

The Oregon Employment Department plans to release the November county and metropolitan area unemployment rates and employment survey data on Tuesday, Dec. 24, and the statewide unemployment rate and employment survey data for November on Wednesday, Dec. 18.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
