Employment in the Columbia Gorge: December 2024

Unemployment Rates Little Changed Over the Month

In December, Hood River County's seasonally adjusted unemployment rate increased marginally to 3.3%, up from 3.2%. Hood River County's unemployment rate ranked as Oregon's second lowest, just above Wheeler's 3.1%. Over the year, the county's seasonally adjusted unemployment rate edged up by 0.2 percentage point.

Hood River County's nonfarm employment increased by 260 (+2.2%) in December and was estimated at 12,210 jobs. While private employment increased over the month (+280 jobs), public employment lost 20 jobs.

Hood River County's private industry employment decreased by 120 jobs over the year ending in December, a loss of 1.0%. Jobs were lost in leisure and hospitality (-120 jobs); manufacturing (-80); professional and business services (-50); and mining, logging, and construction (-20). Gains were seen in private education and health services (+80 jobs); and trade, transportation, and utilities (+60 jobs).

Wasco County's seasonally adjusted unemployment rate increased slightly from 4.0% in November to 4.1% in December. Over the year, Wasco County's seasonally adjusted unemployment rate is 0.1 percentage point higher.

Wasco County's nonfarm employment decreased by 60, totaling 10,280 as of December. Private industry employment lost 40 jobs, bringing employment down to 7,920. The public sector also lost 20 jobs, with government employment now at 2,360. Private job gains were seen in trade, transportation, and utilities (+20 jobs) as well as in manufacturing (+10 jobs). Meanwhile, five other major industries experienced slight losses, while the remaining major industries showed no change over the month.

Wasco County's private-industry employment fell by 140 jobs over the year ending in December. Losses were widespread but mainly concentrated in trade, transportation, and utilities (-70 jobs); professional and business services (-40 jobs); and leisure and hospitality (-20). Gains were minimal and concentrated in other services (+10).

Gilliam County's seasonally adjusted unemployment rate was unchanged in December and over the year, remaining at 4.8%. Gilliam County's nonfarm employment increased by five jobs (+0.6%) from

November to December and is now at 905 jobs. Over the year, the private sector gained 70 jobs (+8.4%), while government employment decreased by 10 jobs and now totals 285 jobs.

Sherman County's seasonally adjusted unemployment rate increased from 3.5% in November to 3.7% in December but declined by 0.4 percentage point over the year. Sherman County's nonfarm employment increased by 15 in December and stands at 950. The public sector gained 30 jobs while leisure and hospitality lost 10 jobs and trade, transportation, and utilities lost five jobs over the month. Over the year ending in December, private industry lost 10 jobs and now stands at 600, down by 1.6%.

Wheeler County's seasonally adjusted unemployment rate edged upward from 3.0% to 3.1% but remains the lowest seasonally adjusted unemployment rate in Oregon. Over the year, Wheeler County's seasonally adjusted unemployment rate increased 0.4 percentage point. Total nonfarm employment lost 15 jobs from November to December and now stands at 370 jobs. Over the year ending in December, private-industry employment rose by 10 and was estimated at 175. Similarly, government employment rose by 10 to reach 195.

Next Press Releases

The Oregon Employment Department plans to release the January county and metropolitan area unemployment rates and employment survey data on Tuesday, March 11, and the statewide unemployment rate and employment survey data for January on Monday, March 10.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
