Employment in Douglas County

Douglas County's Unemployment Rate Edges up to 5.6% in December

Douglas County's seasonally adjusted unemployment rate edged up to 5.6% in December compared with a revised 5.3% in November. Douglas County's record low unemployment rate was set in January 2019 at 4.4%. The rate is up from 5.1% in December 2021. The Oregon seasonally adjusted December rate was 4.5% and the U.S. rate was 3.5%.

Douglas County payroll employment increased a seasonally adjusted 190 jobs in December after a gain of 120 in November and a loss of 50 jobs in October. Douglas County has gained back 86% of the jobs lost in March and April 2020 at the onset of the COVID-19 crisis.

In the not seasonally adjusted private-sector industries in December, there was a seasonal gain in retail trade (30). There were additional gains in leisure and hospitality (70), manufacturing (50), and professional and business services (30). There were seasonal losses in construction (-30) and leisure and hospitality (-20).

Government dropped 130 jobs from losses of 70 in local government and 60 in federal government.

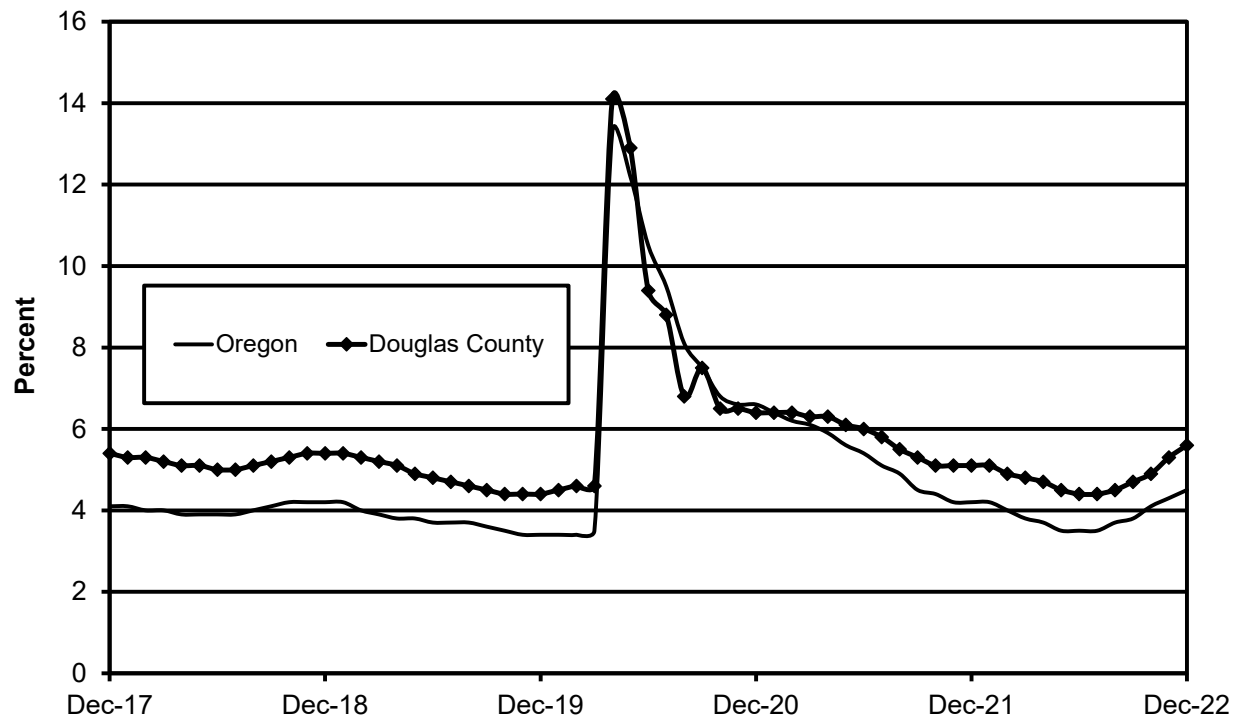
When comparing December 2022 with December 2021, total nonfarm employment increased by 400 jobs, or 1.0%. Large private-sector over-the-year gains were seen in education and health services (180), leisure and hospitality (70), and retail trade (50). There were relatively large losses in professional and business services (-110) and wood product manufacturing (-60).

Government gained 70 jobs over the year from gains in local government (100) and state government (10) that were countered by a loss of 40 in federal government.

The most recent month is preliminary, the prior month is revised. Prepared in cooperation with the U.S. Department of Labor, Bureau of Labor Statistics.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
