Employment in Eastern Oregon: December 2022 Seasonal Losses and Unemployment Increases Continue

Comparing December 2022 with December 2021 shows increasing unemployment rates in all Eastern Oregon counties. The largest over-the-year increase came in Grant County where the raw rate jumped 2.0 percentage points to reach 7.6%. The smallest increase came in Union County where the raw rate increased by 1.2 percentage points to reach 5.3%. The seasonally adjusted unemployment rate rose as well in all Eastern Oregon counties, although at a much slower pace. Grant and Malheur saw the largest increase, rising 0.7 percentage point to 6.7% and 4.6%, respectively. Baker, Union, and Wallowa shared the spotlight for smallest increase over the year, rising by 0.4 percentage point to 4.9%, 5.0%, and 5.5%, respectively. This comes as the number of total employed, which captures the self-employed and unpaid family workers as well as payroll employment, decreased in Eastern Oregon counties.

Baker County's nonfarm payroll employment decreased by 80 since December 2021. Employment decreased by 40 jobs in the private sector as well as 40 jobs in the public sector. Decreases were mainly small with the exception of local government, which dropped by 50. Overall employment decreased by 110 jobs over the month with seasonal cuts in several industries. The seasonally adjusted unemployment rate rose 0.3 percentage point in December to 4.9%. The raw unemployment rate jumped by 0.9 percentage point to 5.7%.

Grant County's nonfarm payroll employment increased by 30 over the year. The private sector dipped by 20 jobs while the public sector increased by 50. Local government (+40) and federal government (+10) were the only industries to see an increase. Over the month, total employment decreased by 80 jobs as seasonal cuts came in six industries. The seasonally adjusted unemployment rate rose 0.3 percentage point in December to 6.7%. The raw unemployment rate jumped by 1.4 percentage points to 7.6%.

Harney County's nonfarm payroll employment ticked up by 10 over the year. The private sector rose by 30 as the public sector dipped by 20. Small gains were seen in a few industries. Local government dropped by 30 for the only loss. Total employment decreased by 90 over the month, with seasonal losses in several industries. The seasonally adjusted unemployment rate rose 0.3 percentage point over the month to 5.4%. The raw unemployment rate jumped by 0.9 percentage point to 6.3%.

Malheur County's nonfarm payroll employment decreased by 60 over the year. The private sector decreased by 30 as the public sector decreased by 30 as well. Retail trade saw the largest decrease over

the year, down 60. Total employment fell by 140 over the month, with seasonal losses in several industries. The seasonally adjusted unemployment rate rose 0.3 percentage point over the month to 4.6%. The raw unemployment rate jumped by 0.8 percentage point to 5.0%.

Union County's total nonfarm payroll employment increased by 80 over the year. The private sector added 40 jobs as the public sector added 40 jobs as well. State government showed the largest gain, up 30. Total employment fell by 140 over the month, mainly from seasonal cuts in federal government, local government, and construction. The seasonally adjusted unemployment rate rose 0.2 percentage point in December to 5.0%. The raw unemployment rate rose by 0.4 percentage point to 5.3%.

Wallowa County's nonfarm payroll employment increased by 70 from December 2021 to December 2022. The private sector added 20 jobs and the public sector added 50. Gains were largest in education and health services (+60) and in local government (+40). Total nonfarm employment decreased by 50 over the month, as seasonal cuts continued in several industries. The seasonally adjusted unemployment rate rose 0.3 percentage point over the month to 5.5%. The raw unemployment rate jumped by 0.9 percentage point for the month to 6.8%.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
