# Employment in Jackson County: January 2025 Total Employment Rose Slightly Over the Year

Total payroll employment in Jackson County fell by 1,480 jobs in January. Retail trade showed the largest decrease, down by 530 jobs over the month. Other industries with estimated declines were health care and social assistance (-200); construction (-200); leisure and hospitality (-190); professional and business services (-100); and transportation, warehousing, and utilities (-100). Government employment fell by 60 with losses in local (-40), and federal (-20) government.

Over the past year, payroll employment in the Medford MSA (Jackson County) rose by 390 jobs, or 0.4%. Since January 2024 industries adding jobs were private education and health services (+670); retail trade (+350); construction (+80); and other services (+80). Industries with over-the-year losses included professional and business services (-270); leisure and hospitality (-160); financial activities (-110); and manufacturing (-50). Government lost 120 jobs since January 2024, with losses in local government (-200) somewhat offset by gains in state (+70) and federal (+10) government.

Jackson County's not seasonally adjusted unemployment rate was estimated at 6.1% in January, up from 4.7% in December and up from 5.6% in January 2024.

The Oregon Employment Department plans to release the February county and metropolitan area unemployment rates and employment survey data on Tuesday, April 1<sup>st</sup>, and the statewide unemployment rate and employment survey data for February on Wednesday, March 26<sup>th</sup>.

#### Notes:

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted. These preliminary estimates of jobs and other labor force data are produced in cooperation with the federal Bureau of Labor Statistics, are based largely on a survey of businesses and a survey of households, and are subject to later revision.

Labor force statistics for Oregon metropolitan statistical areas (MSAs) are produced by the U.S. Department of Labor, Bureau of Labor Statistics. Through June 2025, seasonally adjusted data are not available for Oregon MSAs or other MSAs around the country. New MSA definitions resulting from the 2020 Census are being incorporated into the history of the data series back to 1990, as well as other updates to the processing of labor force estimates for substate areas. Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.
