Employment in Lincoln County: February 2024

Seasonally adjusted employment decreased by 80 in February

Seasonally adjusted nonfarm payroll employment decreased by 80 in February to 18,880 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 140 jobs was expected for the month, but the county's total nonfarm employment increased by 60. The private sector gained 80 jobs. Leisure and hospitality added 80 jobs. Manufacturing declined by 10 jobs. Government employment decreased by 20.

February's total nonfarm employment numbers show a gain of 330 jobs compared with one year before, an increase of 1.8%. Professional and business services was up 120 jobs over the year to February and private education and health services was up by 50 jobs. Accommodation and food services shed 70 jobs over the year. Local government, including tribal and education, added 130 jobs over the past year.

Lincoln County's seasonally adjusted unemployment rate was 4.3% in February, essentially unchanged from 4.2% in January. It was 5.8% the year before. The statewide unemployment rate was 4.2% in February, and the national rate was 3.9%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
