**Employment in Lincoln County: May 2024** 

## Seasonally adjusted employment unchanged in May

Seasonally adjusted nonfarm payroll employment was unchanged in May at 18,630 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 290 jobs was expected for the month, and the county's total nonfarm employment increased by 290. The private sector gained 270 jobs. Leisure and hospitality added 110 jobs. Food manufacturing added 60 jobs. Local government increased by 20.

May's total nonfarm employment numbers were down from one year before by 170 jobs, a decrease of 0.9%. Private education and health services was up 40 jobs over the year in May. Food manufacturing shed 150 jobs over the year. Leisure and hospitality and retail trade each lost 80 jobs. Local government, including tribal and education, added 140 jobs over the past year.

Lincoln County's seasonally adjusted unemployment rate was 4.6% in May, unchanged from 4.6% in April. It was 4.2% the year before. The statewide unemployment rate was 4.2% in May, and the national rate was 4.0%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
