Employment in Lincoln County: June 2024

Seasonally adjusted employment decreased by 90 in June

Seasonally adjusted nonfarm payroll employment decreased by 90 in June to 18,530 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 340 jobs was expected for the month, and the county's total nonfarm employment increased by 250. The private sector gained 240 jobs. Leisure and hospitality added 110 jobs. Manufacturing added 60 jobs. Local government decreased by 30.

June's total nonfarm employment numbers were down from one year before by 350 jobs, a decrease of 1.8%. Private education and health services was up 60 jobs over the year in June. Leisure and hospitality shed 220 jobs over the year. Food manufacturing lost 160 jobs. Local government, including tribal and education, added 40 jobs over the past year.

Lincoln County's seasonally adjusted unemployment rate was 4.6% in June, unchanged from 4.6% in May. It was 4.1% the year before. The statewide unemployment rate was 4.1% in June, and the national rate was 4.1%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
