Employment in Lincoln County: November 2024

Seasonally adjusted employment increased by 30 jobs in November

Seasonally adjusted nonfarm payroll employment increased by 30 in November to 18,680 jobs. Seasonally adjusted figures compare expected changes with actual changes. A loss of 290 jobs was expected for the month. The county's total nonfarm employment actually decreased by 260, with a loss of 280 jobs in the private sector, and a gain of 20 jobs in government. Leisure and hospitality lost 150 jobs. Manufacturing lost 110 jobs. Local government, including tribal and education, added 30 jobs.

November's total nonfarm employment numbers were down by 40 jobs over the year, essentially the same as the year before. The largest gains occurred in private education and health services and professional and business services, which each rose by 50 jobs over the year in November. Manufacturing lost 170 jobs. Financial activities shed 80 jobs over the year. Local government, excluding tribal and education, added 90 jobs.

Lincoln County's seasonally adjusted unemployment rate was 4.8% in November, unchanged from 4.8% in October. It edged up from 4.3% the year before. The statewide unemployment rate was 4.1% in November, and the national rate was 4.2%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
