# **Employment in Lincoln County: February 2025**

## Seasonally adjusted employment decreased by 60 jobs in February

Seasonally adjusted nonfarm payroll employment decreased by 60 in February to 18,800 jobs. Seasonally adjusted figures compare expected changes with actual changes. A gain of 150 jobs was expected for the month. The county's total nonfarm employment actually increased by 90, with a gain of 90 jobs in the private sector, and government employment unchanged. Leisure and hospitality added 80 jobs. Other private industries had little to no change. Government employment was little changed.

February's total nonfarm employment numbers were up by 30 jobs over the year, an increase of 0.2%. The largest gains occurred in professional and business services which rose by 150 jobs over the year in February. Manufacturing lost 220 jobs. Retail trade shed 90 jobs over the year. Local government, excluding tribal and education, added 70 jobs.

Lincoln County's seasonally adjusted unemployment rate was 5.0% in February, up from 4.9% in January. It edged up from 4.5% the year before. The statewide unemployment rate was 4.5% in February, and the national rate was 4.1%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
