# **Employment in Albany MSA (Linn County): October 2023**

## Linn County's Unemployment Rate Remains at 3.8%

Linn County's seasonally adjusted unemployment rate was 3.8% in October, matching its revised rate of 3.8% in September. Oregon's statewide unemployment rate in October was 3.6%, up from its revised September rate of 3.5%.

Linn County's employment gains in October were less than normal; total nonfarm employment increased by 180 jobs, when employment would be expected to increase 240 jobs. As a result, seasonally adjusted employment decreased by 60 jobs between September and October. Employment is now 3.0%, or 1,410 jobs, above the pre-pandemic employment level in February 2020.

Linn County's seasonally adjusted total nonfarm employment was up 1,070 (+2.3%) over the past year.

Private-sector employment was up 70 in October. Industries showing the largest employment gains in October included private education and health services (+100 jobs, +1.3%) and transportation, warehousing, and utilities (+70 jobs, +2.0%).

Public-sector employment was up 110 jobs in October. Local government education employment added 140. State government and federal government employment both declined 20 in October.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
