## **Employment in Albany MSA (Linn County): December 2023**

## Linn County's Unemployment Rate up to 4.0%

Linn County's seasonally adjusted unemployment rate was 4.0% in December, essentially unchanged from its revised rate of 3.9% in November. Oregon's statewide unemployment rate in December was 3.7%, edging up from its revised November rate of 3.6%.

Linn County's employment gains in December were more than normal; total nonfarm employment increased by 430 jobs, when employment would be expected to increase 170 jobs. As a result, seasonally adjusted employment increased by 260 jobs between November and December. Employment is now 3.8%, or 1,800 jobs, above the pre-pandemic employment level in February 2020.

Linn County's seasonally adjusted total nonfarm employment was up 1,160 (+2.4%) over the past year.

Private-sector employment was up 390 in December. Industries showing the largest employment gains in December included retail trade (+140 jobs, +2.5%), private education and health services (+120 jobs, +1.6%), and leisure and hospitality (+90 jobs, +2.4%).

Public-sector employment was up 40 jobs in December. Local government education employment added 80. State government shed 30 jobs while federal government employment was up 10 in December.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
