## Employment in Albany MSA (Linn County): May 2024

## Linn County's Unemployment Rate Remains at 4.6%

Linn County's seasonally adjusted unemployment rate was 4.6% in May, unchanged from its revised rate of 4.6% in April. Oregon's statewide unemployment rate in May was 4.2%, matching its revised April rate of 4.2%.

Linn County's employment gains in May were more than normal; total nonfarm employment increased by 270 jobs, when employment would be expected to increase 190 jobs. As a result, seasonally adjusted employment increased by 80 jobs between April and May. Employment is now 1.6%, or 750 jobs, above the pre-pandemic employment level in February 2020.

Linn County's seasonally adjusted total nonfarm employment was down 320 (-0.7%) over the past year.

Private-sector employment was up 210 in May. Industries showing the largest employment gains in May included manufacturing (+70 jobs, +0.8%); construction (+50 jobs, +1.6%); and private education and health services (+50 jobs, +0.7%).

Public-sector employment was up 60 in May. Local government employment added 70. Federal government employment shed 10 while state government employment was unchanged in May.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Official Oregon Series. Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
