
Employment in South Central Oregon: June 2024

The seasonally adjusted unemployment rate held steady in Klamath County, while in Lake County, the unemployment rate decreased over the month of June. Both counties saw employment gains over the month.

<u>Klamath County:</u> The seasonally adjusted unemployment rate in June was 5.4%, unchanged from May's rate. The unemployment rate in June 2023 was 5.1%.

Klamath County gained 270 jobs (+1.1%) in June, with the majority of gains taking place in leisure and hospitality (+140 jobs) and trade, transportation, and utilities (+50 jobs). Seasonally adjusted employment levels in Klamath County are now 2.4% (+550 jobs) above levels in February 2020 before the onset of the pandemic.

Klamath County gained 250 jobs in the past year (+1.0%). Notable private-sector job losses over the past year were



seen in manufacturing (-120 jobs); trade, transportation, and utilities (-110 jobs); and mining, logging, and construction (-60 jobs). In the public sector, government employment was up by 330 jobs over the year, with the largest gains taking place in local government (+200 jobs). Total nonfarm employment losses were also offset by gains in private education and health services (+160 jobs), other services (+60 jobs), and leisure and hospitality (+40 jobs).

Lake County: The seasonally adjusted unemployment rate decreased from 5.0% in May to 4.8% in June—last June it was 4.7%. The unemployment rate was 4.2% in January 2020, before the impacts of COVID-19 were first felt.

Lake County employment increased by 70 jobs in June (+3.1%), with the only notable monthly gains in the public sector (+50 jobs); other services (+20 jobs); professional business services (+10 jobs); and

mining, logging, and construction (+10 jobs). Losses were concentrated in private education and health services (-10 jobs) and manufacturing (-10 jobs). As of June 2024, seasonally adjusted total nonfarm employment levels remain 170 jobs (-7.1%) below the pre-pandemic February 2020 employment levels.

Lake County's total nonfarm employment is down by 130 jobs (-5.3%) year-over-year. Gains were marginal and concentrated in other services (+10 jobs). These gains were overshadowed by losses in the public sector (-100 jobs), with most of the losses taking place in local government (-100 jobs). Smaller losses were also seen in trade, transportation, and utilities (-20 jobs); leisure and hospitality (-10 jobs); and mining, logging, and construction (-10 jobs). All other major industries saw little to no change over the year.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
