
## **Employment in South Central Oregon: September 2024**

Seasonally adjusted unemployment rates saw no change in South Central Oregon this September as county unemployment rates held steady.

**Klamath County:** The seasonally adjusted unemployment rate in September was 5.4%, unchanged from August's rate. The unemployment rate in September 2023 was 5.1%.

Klamath County gained 300 jobs (+1.2%) in September, with the majority of gains taking place in the public sector (+460 jobs), and most losses occurring in leisure and hospitality (-110 jobs). Seasonally adjusted employment levels in Klamath County are now 3.5% (+820 jobs) above levels in February 2020 before the onset of the pandemic.

Klamath County gained 110 jobs in the past year (+0.5%) with gains concentrated in



leaisure and hospitality (+170 jobs) and private education and health services (+140 jobs). Private-sector job losses over the past year were seen in other services (-90 jobs); professional and business services (-90 jobs); manufacturing (-60 jobs); and financial activities (-50 jobs).

**Lake County**: The seasonally adjusted unemployment rate remained unchanged from August to September at 4.9%—last September it was 5.1%. The unemployment rate was 4.2% in January 2020, before the impacts of COVID-19 were first felt.

Lake County employment decreased by 20 jobs in September (-0.9%). Small job gains were seen in manufacturing (+20 jobs) and retail trade (+10 jobs). These gains were offset by losses in the public sector (-50 jobs) and leisure and hospitality (-20 jobs). Seasonally adjusted total nonfarm employment levels remain 140 jobs (-5.9%) below the pre-pandemic February 2020 employment levels, as of September.

Lake County's total nonfarm employment is down by 10 jobs (-0.4%) year-over-year, with the only notable gains taking place in other services (+30 jobs); manufacturing (+20 jobs); and trade, transportation, and utilities (+10 jobs). Losses were concentrated in the public sector (-50 jobs), primarily in local government (-50 jobs). Other lesser, but notable losses occurred in leisure and hospitality (-20 jobs). All other major industries saw little to no change over the year.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
