Employment in South Coast: April 2024 South Coast Employment Slips Over the Year

Coos County total payroll employment fell by 40 jobs in April. Job gains were small but noted in several industries. Those adding jobs included leisure and hospitality (+40); manufacturing (+30); construction (+20); and professional and business services (+20). Transportation, warehousing, and utilities employment declined by 20 jobs in April. Government employment fell by 110 jobs over the month. A loss of 130 jobs in local government education was slightly countered by the 20 jobs added in non-education and tribal local government.

Since April 2023, Coos County has lost 160 payroll jobs, a decline of 0.7%. The largest job losses occurred in professional and business services, down by 230 jobs. Other industries with jobs losses included transportation, warehousing, and utilities (-60); retail trade (-40); leisure and hospitality (-30); and information (-20). Government employment rose by 150 jobs over the year with local government excluding education and tribal (+110), and Indian tribal (+60) accounting for the gain.

Curry County payroll employment climbed by 50 jobs in April. Leisure and hospitality added 50 jobs, the only published sector with a notable employment gain.

Over the past year, Curry County lost 260 payroll employment jobs. Industries showing job losses since April 2023 included retail trade (-100); leisure and hospitality (-100); construction (-30); and private education and health services (-20).

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
