## **Employment in South Coast: May 2024 South Coast Employment Climbs in May**

Coos County total payroll employment increased by 240 jobs in May. Private-sector gains were small but noted in several industries. Those adding jobs included leisure and hospitality (+30); food manufacturing (+20); professional and business services (+20); and private educational and health services (+20). Transportation, warehousing, and utilities employment rose by 20 jobs in May. Government employment rose by 130 jobs over the month. A gain of 150 jobs in local government education was slightly countered by 30 jobs lost in non-education and 10 in tribal local government.

Since May 2023, Coos County has lost 180 payroll jobs, a decline of 0.8%. The largest job losses occurred in professional and business services, down by 160 jobs. Other industries with job losses included transportation, warehousing, and utilities (-70); retail trade (-60); leisure and hospitality (-50); and construction (-20). Government employment rose by 120 jobs over the year with local government excluding education and tribal (+70), and Indian tribal (+50) accounting for the gain.

Curry County payroll employment climbed by 110 jobs in May. Leisure and hospitality added 60 jobs. Trade, transportation, and utilities employment rose by 30 over the month. Government added 20 jobs in May.

Over the past year, Curry County lost 260 payroll employment jobs. Industries showing job losses since May 2023 included retail trade (-110); leisure and hospitality (-100); construction (-20); and private education and health services (-10). Government employment rose 20.

## **Next Press Releases**

The Oregon Employment Department plans to release the June county and metropolitan area unemployment rates and employment survey data on Tuesday, July 23<sup>rd</sup>, and the statewide unemployment rate and employment survey data for June on Wednesday, July 17<sup>th</sup>.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this official Oregon series unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
