# **Employment in South Coast: July 2024 South Coast Employment Dips in July**

Coos County total payroll employment decreased by 300 jobs in July. Government employment fell by 420, mostly due to seasonally typical declines in local government education. Private-sector gains were estimated in several industries and totaled 120 jobs added over the month. Those adding jobs were leisure and hospitality (+70); construction (+30); manufacturing (+20); and other services (+20). Transportation, warehousing, and utilities lost 30 jobs, and private educational and health services shed 20 jobs in July.

Since July 2023, Coos County has lost 300 payroll jobs, a decline of 1.3%. Employment gains occurred in manufacturing (+80); private education and health services (+70); leisure and hospitality (+30); and other services (+30). The largest job losses occurred in professional and business services, down by 470 jobs. Other industries with job losses included transportation, warehousing, and utilities (-60); wholesale trade (-40); mining and logging (-30); and retail trade (-20). Government employment rose by 130 jobs over the year, with local government (+110) and federal government (+20) accounting for the gain.

Curry County payroll employment slipped by 40 jobs in July. Government employment declined by 90 jobs, mostly due to seasonal reductions in local government education. Leisure and hospitality added 60 jobs, the only published sector gaining notable jobs.

Over the past year, Curry County lost 260 payroll employment jobs. Industries showing job losses since July 2023 included leisure and hospitality (-130) and retail trade (-90). Government employment fell by 10. A loss of 20 jobs in local government was offset by a gain of 10 in federal government.

# **Next Press Releases**

The Oregon Employment Department plans to release the August county and metropolitan area unemployment rates and employment survey data on Tuesday, September 24<sup>th</sup>, and the statewide unemployment rate and employment survey data for August on Wednesday, September 18<sup>th</sup>.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
