Employment in South Coast: November 2024 South Coast Employment Mixed Over the Year as Coos County Sees Gains

Coos County total payroll employment slipped by 30 jobs in November. Industries with losses over the month were leisure and hospitality (-30); professional and business services (-30); construction (-30); and food manufacturing (-20). Slight employment gains were estimated in retail trade (+20), and transportation, warehousing, and utilities (+20). Government employment rose by 60 jobs with gains in local government education (+70), and local government excluding education and tribal (+20). Those gains were slightly offset by losses of 10 in federal, state, and Indian tribal government employment.

Since November 2023, Coos County has gained 420 payroll jobs, an increase of 1.8%. Employment gains occurred in leisure and hospitality (+130); other services (+110); professional and business services (+80); manufacturing (+40); and private education and health services (+40). The largest job loss occurred in retail trade, down by 110 jobs. Other industries with job losses included wholesale trade (-40), and mining and logging (-30). Government employment rose by 180 jobs over the year, with local government (+190) accounting for the gain.

Curry County payroll employment fell by 100 jobs in November. Leisure and hospitality lost 90 jobs while retail trade employment slipped by 10. Construction also lost 10 jobs.

Over the past year, Curry County lost 60 payroll employment jobs. Industries showing job declines since November 2023 included retail trade (-90); financial activities (-50); and mining, logging, and construction (-20). Leisure and hospitality (+40), and professional and business services (+20) added jobs since November 2023. Government employment rose by 60, with the increase occurring in local government excluding educational services.

The Oregon Employment Department plans to release the December county and metropolitan area unemployment rates and employment survey data on Tuesday, Jan. 28th, and the statewide unemployment rate and employment survey data for December on Thursday, Jan. 23rd.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
