Employment in South Coast: February 2025 Coos County Sees Gains Over the Year, Curry Loses Jobs

Coos County total payroll employment rose by 240 jobs in February. Local government education posted the largest gain, adding 260 jobs over the month – a typical seasonal increase. Other industries with estimated employment increases included professional and business services (+50); leisure and hospitality (+30); retail trade (+30); and construction (+20).

Since February 2024, Coos County has gained 240 payroll jobs, an increase of 1.0%. Employment gains occurred in professional and business services (+90); leisure and hospitality (+70); manufacturing (+60); and retail trade (+20). Government employment rose by 20 jobs over the year. Local government gained 40 jobs and federal government employment fell by 20 jobs over the year.

Curry County payroll employment rose by 40 jobs in February. Employment changes were small with construction; professional and business services; private education and health services; and leisure and hospitality up by 10 jobs over the month.

Over the past year, Curry County payroll employment fell by 40 jobs, a decrease of 0.6%. Losses were estimated in leisure and hospitality (-60); retail trade (-30); and financial activities (-20). A few industries added jobs over the year, including manufacturing (+20), health care (+30), and state government (+20).

The Oregon Employment Department plans to release the March county and metropolitan area unemployment rates and employment survey data on Tuesday, April 22nd, and the statewide unemployment rate and employment survey data for March on Wednesday, April 16th.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
