## **Employment in Tillamook County: October 2023**

# Seasonally adjusted employment decreased by 20 in October

Seasonally adjusted nonfarm payroll employment fell by 20 in October to 9,710 jobs. Seasonally adjusted figures compare expected changes with actual changes. Employment was expected to decrease by 100 jobs, and the county lost 120 jobs. The private sector lost 160 jobs, and total government employment increased by 40. Leisure and hospitality lost 130 jobs. Trade, transportation, and utilities lost 30 jobs. Local education added 40 jobs.

October's total nonfarm employment numbers show a gain of 240 jobs compared with one year before, an increase of 2.5%. The county lost 1,260 jobs in March 2020 as the pandemic hit, and as of October it surpassed its pre-pandemic level from October 2019 by 150 jobs. Food manufacturing grew by 130 jobs over the past year to October. Leisure and hospitality added 70 jobs. Private education and health services lost 110 jobs during the year. Government gained 40 jobs over the year.

Tillamook County's seasonally adjusted unemployment rate was 3.6% in October, little changed from 3.7% in September. It was 5.0% the year before. The statewide unemployment rate was 3.6% in October, and the national rate was 3.9%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
