Employment in Tillamook County: December 2023

Seasonally adjusted employment unchanged in December

Seasonally adjusted nonfarm payroll employment stayed steady in December at 9,710 jobs. Seasonally adjusted figures compare expected changes with actual changes. Employment was expected to decrease by 90 jobs, and the county lost 90 jobs. The private sector lost 100 jobs, and total government employment increased by 10. Leisure and hospitality lost 70 jobs. Local education added 10 jobs.

December's total nonfarm employment numbers show a gain of 170 jobs compared with one year before, an increase of 1.8%. Food manufacturing grew by 100 jobs over the past year to December. Leisure and hospitality added 50 jobs. Private education and health services lost 80 jobs during the year. Government gained 70 jobs over the year.

Tillamook County's seasonally adjusted unemployment rate was 3.7% in December, essentially unchanged from 3.6% in November. It was 5.0% the year before. The statewide unemployment rate was 3.7% in December, and the national rate was 3.7%.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
