Employment in Tillamook County: July 2024

Seasonally adjusted employment decreased by 30 jobs in July

Seasonally adjusted nonfarm payroll employment decreased by 30 in July to 9,400 jobs. Seasonally adjusted figures compare expected changes with actual changes. Employment was expected to increase by 100 jobs. The county added 70 jobs, with a gain of 160 jobs in the private sector, and a government employment decrease of 90.

Leisure and hospitality added 70 jobs over the month. Manufacturing added 40 jobs. Local education lost 70 jobs.

July's total nonfarm employment was down from the previous year by 200 jobs, a decrease of 2.1%. Accommodation and food services had the largest gain, adding 30 jobs (2.0%) over the past year. Private education and health services lost 110 jobs during the year, a decline of 9.6%. Local education gained 50 jobs over the year.

Tillamook County's seasonally adjusted unemployment rate was 3.9% in July, which was unchanged from June. It was 3.7% the year before. The statewide unemployment rate was 4.1% in July, and the national rate was 4.3%.

Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants.

Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
