Employment in Tillamook County: September 2024

Seasonally adjusted employment increased by 50 in September

Seasonally adjusted nonfarm payroll employment increased by 50 in September to 9,470 jobs. Seasonally adjusted figures compare expected changes with actual changes. Employment was expected to decrease by 160 jobs, and the county lost 110 jobs, with a loss of 120 jobs in the private sector, and a government employment increase of 10. Private education and health services gained the most jobs with an increase of 40. Leisure and hospitality lost 70 jobs. Government employment was little changed.

September's total nonfarm employment was down from the previous year by 210 jobs, a decrease of 2.1%. Food services and drinking places had the largest gain, adding 20 jobs (2.0%) over the past year. Food manufacturing lost 100 jobs during the year, a decline of 7.8%. Local education gained 30 jobs over the year.

Tillamook County's seasonally adjusted unemployment rate was 3.9% in September, which was unchanged from August. It was 3.8% the year before. The statewide unemployment rate was 4.0% in September, and the national rate was 4.1%.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
