Employment in Tillamook County: November 2024

Seasonally adjusted employment decreased by 60 in November

Seasonally adjusted nonfarm payroll employment decreased by 60 in November to 9,590 jobs. Seasonally adjusted figures compare expected changes with actual changes. Employment was expected to decrease by 80 jobs, and the county lost 140 jobs, with a loss of 110 jobs in the private sector, and a loss of 30 jobs in total government employment. Leisure and hospitality lost 70 jobs. Local education lost 20 jobs.

November's total nonfarm employment was down from the previous year by 80 jobs, a decrease of 0.8%. Private education and health services and leisure and hospitality had the largest gains, adding 40 jobs each (3.7% and 2.9%, respectively) over the past year. Food manufacturing lost 140 jobs during the year, a decline of 10.7%. Government employment has had minimal changes over the year.

Tillamook County's seasonally adjusted unemployment rate was 3.9% in November, which was unchanged from October. It was 3.8% the year before. The statewide unemployment rate was 4.1% in November, and the national rate was 4.2%.

Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
