Employment in Tillamook County: December 2024

Seasonally adjusted employment decreased by 20 in December

Seasonally adjusted nonfarm payroll employment decreased by 20 in December to 9,580 jobs. Seasonally adjusted figures compare expected changes with actual changes. Employment was expected to decrease by 70 jobs, and the county lost 90 jobs, with a loss of 90 jobs in the private sector, and no change in total government employment. Leisure and hospitality lost 60 jobs. Other industries had little or no change.

December's total nonfarm employment was up from the previous year by 30 jobs, an increase of 0.3%. Private education and health services had the largest gains, adding 50 jobs (3.7%) over the past year. Food manufacturing lost 50 jobs during the year, a decline of 4.2%. State government added 30 jobs over the year (8.5%).

Tillamook County's seasonally adjusted unemployment rate was 3.9% in December, which was unchanged from November. It was 3.8% the year before. The statewide unemployment rate was 4.1% in December, and the national rate was 4.1%.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
