Employment in Yamhill County: December 2022

Yamhill County's Unemployment Rate Increases to 3.9%

Yamhill County's seasonally adjusted unemployment rate was 3.9% in December, up from its revised rate of 3.7% in November. Oregon's statewide unemployment rate in December was 4.5%, up from its revised November rate of 4.3%.

Yamhill County's employment losses in December were less than normal; total nonfarm employment decreased 320 jobs, when an employment decrease of 530 jobs would be expected. As a result, seasonally adjusted employment was up 210 in December. Employment is 1.0%, or 370 jobs, above the pre-pandemic level in February 2020.

The private sector shed 320 jobs in December. Sectors losing the most employment in December were private educational services (-160 jobs, -4.7%), manufacturing (-80 jobs, -1.1%), and leisure and hospitality (-60 jobs, -1.7%).

The largest gains were in health care and social assistance (+30 jobs, +0.6%) and financial activities (+10 jobs, +0.8%).

Yamhill County's public-sector employment was unchanged in December. Local government employment grew 10. Federal government employment declined 10 in December.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence.

Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants.

Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
