## **Employment in Yamhill County: September 2024**

## Yamhill County's Unemployment Rate Remains at 3.6%

Yamhill County's seasonally adjusted unemployment rate was 3.6% in September, matching its revised rate of 3.6% in August. Oregon's statewide unemployment rate in September was 4.0%, unchanged from its revised August rate of 4.0%.

Yamhill County's employment gains in September were slightly more than normal; total nonfarm employment increased 1,100 jobs, when an employment increase of 1,030 jobs would be expected. As a result, seasonally adjusted employment was up 70 in September. Employment is 1,330 jobs (+3.8%) above the pre-pandemic level in February 2020.

The private sector added 670 jobs in September. The largest industry employment gains in September were in private education services (+640 jobs, +31.7%) and manufacturing (+110 jobs, +1.6%).

The largest private-sector industry employment losses in September were reported in other services (-40 jobs, -3.3%), leisure and hospitality (-20 jobs, -0.5%), and retail trade (-20 jobs, -0.5%).

Yamhill County's public-sector employment was up 430 in September. Local government was up 430 jobs with the beginning of the school year. Federal government employment and state government employment were both unchanged in September.

Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
