## **Employment in Yamhill County: January 2025**

## Yamhill County's Unemployment Rate Edges up to 4.1%

Yamhill County's seasonally adjusted unemployment rate was 4.1% in January, edging up from its revised rate of 3.9% in December. Oregon's statewide unemployment rate in January was 4.4%, up from its revised December rate of 4.3%.

Yamhill County's employment losses in January were less than normal; total nonfarm employment decreased 920 jobs, when an employment decrease of 960 jobs would be expected. As a result, seasonally adjusted employment was up 40 in January. Employment is 1,600 jobs (+4.5%) above the pre-pandemic level in February 2020.

The private sector shed 930 jobs in January. The largest private-sector industry employment losses in January were reported in private educational services (-290 jobs, -10.4%), and health care and social assistance (-140 jobs, -2.0%).

Yamhill County's public-sector employment was up 10 in January. Local government and state government were both unchanged in January. Federal government was up 10 jobs in January.

Civilian labor force includes employed and unemployed individuals 16 years and older by place of residence. Employed includes payroll employment, self-employed, unpaid family workers, domestics, agriculture, and labor disputants. Unemployment rate is calculated by dividing unemployed by civilian labor force.

Nonfarm Payroll Employment: Data are by place of work and cover full- and part-time employees who worked or received pay for the pay period that includes the 12th of the month. The data exclude the self-employed, volunteers, unpaid family workers, and domestics.

The Oregon Employment Department and the U.S. Bureau of Labor Statistics (BLS) work cooperatively to develop and publish monthly payroll employment and labor force data for Oregon's metropolitan areas and counties. The estimates of monthly job gains and losses are based on a survey of businesses. The estimates of unemployment are based on a survey of households and other sources.

The Oregon Employment Department payroll employment estimates are revised quarterly using information from unemployment insurance tax records. All department publications use data from this *official Oregon series* unless noted.

The department also makes the BLS-produced nonfarm payroll employment series for metropolitan areas available. These are revised annually by BLS.
