

Total job numbers have recovered since Pandemic


Columbia County Employment and Wages

April 2023 Employment (not seasonally adjusted) and 2022 Annual Wages





Employment Change 2019-2023














Oregon Labor Force Participation Rates by Age Group






Hourly earnings outpaced inflation 2022-2023



Job vacancies have outnumbered unemployed in NW Oregon






